As the Spring season progresses, days and nights become milder, flowers and plants begin to bloom, and the days become longer. This spring, there are many exciting projects that will bring new life into the Town of Binghamton!

First of all, Nick Pappas, our Town Code Enforcement Officer, has been instrumental in having 3492 Margery Street torn down by the Broome County Land Bank Corporation. For many years that property has had a negative impact on the Park Terrance neighborhood. I want to thank Nick for his persistence and dedication to the demolition of that house. Also, back in January, the Town was awarded a \$500,000 grant (Community Development Block Grant) from Homes and Community Renewal of New York. This grant gives the Town's low-income residents the opportunity to apply for assistance for home improvement projects. More information will be available in the coming weeks. Please check our website for updates.

For those of you who may not have heard, 80 acres of the Vestal Hills Country Club are being sold to Broome County for a Veterans Resource Center. This is a great opportunity for Broome County to consolidate many Veterans' programs under one roof. The Town had the pleasure of having Jason Garner and Scott Mastin make a presentation at our March 19th Board meeting and many questions were answered.

Some of you may recall that in the Spring 2017 issue of *Town Talk*, Supervisor Whitesell had mentioned that the Town was looking to offer a way to save on electric bills through MEGA (Municipal Electric and Gas Alliance), a new residential bulk electricity purchasing program. Last month, we were at the end stages to finalize the process. After much discussion, we decided to stop moving forward. Part of the reason was that there was concern about the "opt out" portion of the agreement. If the agreement had been signed, it would have meant that ALL residents would automatically be signed up with the understanding that they could "opt out" within 30 days. There was concern that not all residents would understand they needed to "opt out". With all of that said, the issue has now been dropped, and we wanted to let you know.

Last, but not least, for the first time in at least 11 years, the Town will participate in "Municipal Cleanup Days". With the help of Mike Donahue and the Highway Department, Town residents will be allowed to drop off household items at the Highway Department on June 6th and 7th. *(Details on Page 2.)* The Town will be sending out a postcard to residents sometime in late May, outlining the details. Be sure to watch the Town's website after May 22. Please take advantage of this great opportunity and do your part to clean up the Town of Binghamton!

Finally, I would like to thank all of the employees of the Town of Binghamton for their help in making my first 120 days in office a success.

IT'S THE LAW! – This is a reminder that it is a violation of the law for any person to stop, stand, or park a vehicle in an area designated as a parking place for the disabled unless the vehicle has a parking permit or license plates for the disabled and is being used to transport a person with a severe disability. The maximum fine for a violation ranges from \$75 to \$450.



The hanging style parking permit for the permanently or temporarily disabled is available at the

Town Clerk's office. The single permit is issued immediately at no cost when the required form is filled out by your physician as well as when your driver's license (if applicable) is presented. The license plates for the permanently disabled are issued at the Department of Motor Vehicles upon submission of the same form completed by your physician. The plates are issued at a cost of \$25.

WHAT IS "TAXABLE STATUS DATE"? John McDonald, Assessor



Here's just a bit of information about the tax year. The tax year, for assessment purposes, is a fiscal year that begins July 1 and runs through the following June 30. Each year the Assessor's Office establishes a new tentative tax roll on May 1 that goes into effect on July 1.

The assessment that is shown on that new July 1 tax roll reflects the status of the property on March 1, which is called "taxable status date". This becomes important information for you if you are building a new house, constructing an addition to your existing house, demolishing a building, etc.

As an example, if your home is 50% complete as of March 1, the July 1 tax roll reflects 50% of the finished value of the home. The assessment then does not change again until the following tax year, because once the July 1 tax roll becomes effective, it is frozen by law and cannot change (up or down).

We are more than ready for spring around here! Just like past winters, we have been dealt our fair share of cold and snowy weather. This means we are ready to move on and start with spring cleanup, including brush and debris removal, filling pot holes, road sweeping, and sign maintenance. As the season continues, we will move on to ditch cleaning and paving during the summer.

We have some projects scheduled for late spring and early summer. In Orchard Park, we'll be replacing the main storm sewer line on Cheryl Drive. We'll also be doing some pipe lining in various locations throughout the town. NYSEG has also informed us that they will be continuing their work throughout the town, replacing some gas services on Moore Avenue, Karen Court, and Carol Court.

As some of you may know, winter can wreak havoc on your driveways and pipes. If you notice you are in need of a new driveway pipe, the Town will **install** one at no cost, but the homeowner is responsible for the cost of the pipe. Just give us a call at 669-4323, and we'll measure it and get a price for the pipe for you!

SPRING TREE BRANCH & BRUSH PICKUP - MAY 6 to MAY 29, 2019

The Town of Binghamton Highway Dept. will be picking up branches on <u>MONDAYS & TUESDAYS ONLY</u> beginning Monday, May 6 and ending Weds., May 29. (LAST PICKUP WILL BE ON <u>WEDNESDAY</u>, MAY 29 BECAUSE OF THE MEMORIAL DAY HOLIDAY.)

This pickup is for TREE BRANCHES ONLY. No cuttings from any kind of bush.

Please call the Highway Dept. at 669-4323 to have your name placed on our list. Due to the overwhelming response to this service, you will not be given a specific time or day when your brush will be picked up.

In addition, there are certain guidelines to be followed:

- 1. Tree branches from your yard only;
- 2. Put branches neatly along the curb/roadside in front of your home;
- 3. Please place the large end of the branch towards the road, and leave the branches as long as possible;
- 4. No brush from clearing your lot;
- 5. No brush from contractors or landscapers; (This means if you hire someone to maintain your lawn, they need to dispose of the debris; we will not take it.)
- 6. Large piles must be approved.

The following items WILL NOT BE ACCEPTED and will be left behind: tree trunks; roots of any sort; clippings from lawns, flower beds, or vegetable gardens; thorny brush and small twigs; leaves and animal waste.



The Water/Sewer Billing Schedule for 2019 is as follows: (these are approximate mailing dates)

November 1, 2018 (1st billing of a cycle); due in early Dec. February 1, 2019 (2nd billing); due in early March May 1, 2019 (3rd billing); due in early June August 1, 2019 (4th billing); due in early September

With that said, **Property Maintenance** has already become the topic of discussion lately, so I wanted to give you a heads up that some of you may be receiving letters asking you to clean up around your homes. Let me say that if you receive a letter from this office, and if you respond

immediately, we'll get along just fine. I'm always willing to work with the property owner as long as corrective action is taken within a reasonable amount of time. If the property owner does not respond to my letter by calling the office and speaking with me, my only option is to turn the issue over to Court. I would have to agree that it really would be nice to see property owners sprucing up their homes this spring!

I'd like to also mention that the **Town Code** is available on our website (under "Building Codes & Permits"). It's a great way to familiarize yourself with what is and what is not acceptable in our Town.

Brush Burn Ban is currently in effect. Absolutely no burning through May 14th.

Finally, I've discovered several people building without a building permit this spring. Please call my office before beginning any new building project. Some projects require a permit and some do not. If you don't know, just give me a call. I'm always happy to help. Thanks!



On March 14, 2019, Town of Binghamton resident Lt. Chris Streno from the Vestal Police Department presented the program "Civilian Response to Active Shooter Event" (CRASE) to a gathering of 25-30 residents and interested parties. The program was superbly presented and extremely informative. Interesting to note, more than half of these events take place in a commerce location and 45% of shooters have no connection to the location. There are three stages of civilian response: Denial, Deliberation, and Decisive Moment. The speed getting from Denial to Decisive Action can determine survival.

Tips: Plan ahead; know exits; script a plan

REMEMBER IN AN EVENT: WHAT YOU DO MATTERS: AVOID (get out of the area); DENY (access to where you are); DEFEND (when no other choice)

There was so much more information. Many positive comments circulated after the meeting. Thank you to Lt. Chris Streno for getting this important information out. Thank you, also, to David Adler from NYS Emergency Response Services for attending and providing literature for attendees.

Our next meeting will be Thursday, June 6th at 7 p.m. at the Community Center. The plan is to have a program from NY State Emergency Response Services.
